PHILOSOPHY

At Happy Valley Children's Ranch, we believe that an environment that is safe and nurturing is essential to the healthy development of children. We provide an educational experience for preschool children that fosters language, physical, social and emotional development. Our caring and supportive staff offers extensive experience in Early Childhood Education.

PROGRAM

Happy Valley Children's Ranch offers a preschool program for children ages 3 to 5 years old. Classes are in session from Aug 25th through May 25th, Monday through Friday. The children who attend come to school either one, two, three or four times per week for a two and one half hour session. **(Four day program offered only to Pre-K classes in the afternoon).** We offer a morning session (8:30A.M.-11:00A.M. or 8:45A.M.-11:15A.M), and an afternoon session (11:45A.M. - 2:15P.M. or 12:00P.M.-2:30P.M). Open house is Sat. Aug 21st (9:00AM - 1:00PM).

A unique part of the program at Happy Valley is our ranch type setting. During outside time the children are offered rides on the ponies or wagon. They also enjoy feeding and petting the other barn animals (chickens, sheep, ducks, rabbits and pig). Check out our website at happyvalleyps.com for more info.

COST

Enrollment fee: A \$60.00 per child or \$85.00 per family **non-refundable** fee is due at the time of enrollment. Program space is limited and this will hold a space for your child. After registration form is submitted, you are notified **only** if your first choice is unavailable. Final confirmations are sent in July.
